


## **KEEPING OUR WORKFORCE SAFE**

Resolution Copper closed Q2 2022 with an AIFR of 0.00.







Resolution Copper and WestLand Tribal Monitors hosted a number of Native American Tribes for tours of our private lands that will transfer to the United States and managed by the Forest Service or Bureau of Land Management as part of the land exchange.

The offered lands lie within varied ecological and cultural contexts in areas that range from Tucson to Payson. These engagements enrich our understanding of the different cultures and perspectives, and provide an opportunity for our company to learn about the landscape and biodiversity through the lens of traditional ecological knowledge holders with ancestral ties to land.
